## PCI DSS Prioritized Approach Summary of Changes from PCI DSS Version 2.0 to 3.0

Type of Change	Details
General	The title and description for Milestone 2 has been updated to reflect the control areas that are now addressed in this milestone.
	• Requirements have been updated to align with PCI DSS version 3.0. Where a PCI DSS requirement was restructured, its previous milestone number was retained unless noted below. (For example, former Requirement 2.2.2 was updated in PCI DSS version 3.0 and is now Requirements 2.2.2 and 2.2.3. The previous milestone number for Requirement 2.2.2 is retained and also applies to Requirement 2.2.3.)
	PCI DSS requirements that were previously combined in the Prioritized Approach Tool have been separated to clarify which requirement the milestone applies to. (For example, Requirements 1.1 and 1.1.1).
	• A requirement that is met in its entirety by its sub-requirements does not have an additional milestone number assigned. (For example, Requirement 1.1).
