Are you Qualified Integrator & Reseller (QIR) material?

Here's a checklist of core business requirements:

- ✔ You are a direct provider or licensed/authorized third-party installer of a PA-DSS validated payment application
- ✔ Must have experience installing and/or configuring payment applications
- ✔ Must have personnel background checks for each employee to be qualified (where legally permitted)
- ✔ Must have a quality assurance manager (need not be full-time) and a quality assurance policy
- ✔ Must have confidential and sensitive data-protection handling practices, including physical, electronic, and procedural safeguards
- ✔ Must agree to a three year QIR Implementation Statement retention policy
- ✔ Must maintain employee(s) with QIR training to retain listing on the PCI SSC website

Key elements of the QIR program

- **Application** – determines eligibility for the QIR Program
- **Education** – comprehensive training outlining best practices including use of QIR Implementation Instructions and Implementation Statement - provides the foundation for ensuring that the payment application will be installed and configured in a manner that supports compliance with PCI DSS.
- **Website listing** – simplifies the process for identifying and engaging integrators and resellers qualified to assist merchants and industry participants in their effort to install validated PA-DSS payment applications in a manner that facilitates PCI DSS compliance.
- **Requalification every 3 years** – ensures integrators/resellers are up to date with the latest, most current version of the PCI DSS.



About the training

Training is done online so integrators/resellers around the world can take the eLearning course at their convenience – 24/7/365 without incurring additional travel expenses.

The self-paced QIR training is comprised of two parts:

- An online prerequisite course (QIR Security Fundamentals) and exam.
- Followed by the QIR Qualification eLearning course and final exam*.

Typical time required to complete both parts is nine (9) hours but since it is self-paced, candidates can start and stop as their schedules permit.

* Note, the QIR final exam will take place at a local authorized Pearson VUE Test Center.
