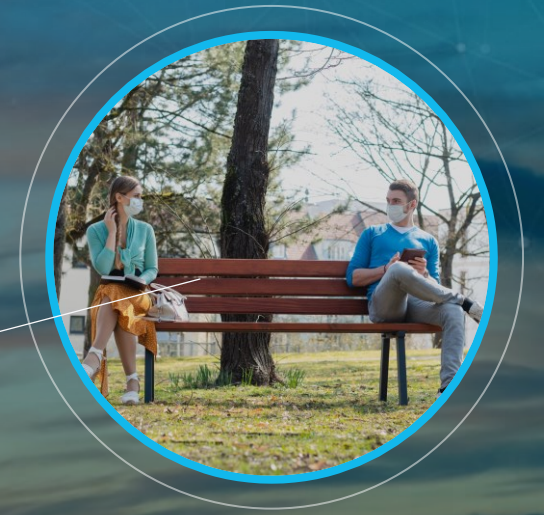

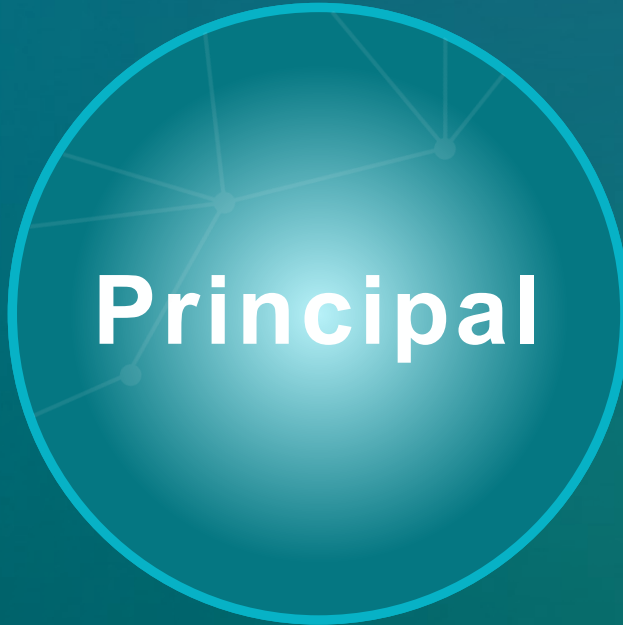

Benefits of being a PCI SSC Participating Organization
